# A MESSAGE FROM OUR CEO

On June 16, 2021 Ohio Senator Sherrod Brown introduced historic legislation to update the long neglected Supplemental Security Income (SSI) program, and the time to make your voice heard is now!

Imagine being told you could only have \$2,000 across your entire asset portfolio. For over 30 years, there has been an asset limit that states people who get SSI can only have \$2,000 in assets. The last time the limit was updated to this level was in 1989. Assets include money across bank accounts, retirement accounts, and savings. These asset limits mean that people cannot save money and force people with disabilities to remain in poverty. If they make or have over \$2,000, it disqualifies them from their benefits, affecting their ability to receive EP!C services.

For EP!C these limits can look like our staff or guardians trying to find ways to help individuals spend their money, whether they want to or not, so they remain eligible. It could be going on a vacation, having an experience, or purchasing something for themselves. This all sounds nice, but if the individual doesn't want to spend their money, they shouldn't have to. The same goes for someone saving for something larger; they could never exceed \$2,000 of their full assets. There is no "saving for a rainy day" with the current penalties.

**TAKE ACTION:** Urge your U.S Senators to support people with disabilities and their families by co-sponsoring the bipartisan SSI Savings Penalty Elimination Act (S.4102) which would raise these asset limits.

\*It's important to note, SSI benefits have never been large enough to raise an individual's income past the federal poverty line. SSI's maximum is \$841/mo. where the poverty line is \$1,133/mo.
