#### A MESSAGE FROM **OUR CEO**

KIM CORNWELL EP!C CEO

During the State's FY2024 budget process we had several opportunities for advocacy that could help lead to positive changes for agencies just like ours.

When it comes to rate reimbursement for services provided the original proposed amount was \$1.50. Organizations across the state rallied together to demand a \$4.00 increase that would allow us to pay a professional wage and compete with the rising minimum wage. Thanks in part to your involvement, we are grateful to share they settled at a rate of \$2.50/hour.



Another piece of our funding puzzle is the formula in which reimbursement rates are calculated. Because of the 2020 Guidehouse Study that formula was being updated. Unbeknownst to provider agencies like EP!C and IDHS staff, the new formula funded fewer DSP hours. For EP!C, this meant a decline of 45,468 DSP hours and \$525,000 less in funding per year. Due to the proposed elimination of DSP hours and the uproar over this proposal, IDHS had agreed to freeze the 2022 rate formulas until October as they bring in a third party to analyze the new formula and find out why it was projecting cuts in DSP hours. EP!C submitted our numbers and outcomes as evidence in hopes it adds to the urgency of rectifying and funding the rates properly.

I want to personally thank each and every one of you who took the time to make your voice heard by filing out a witness slip, sending an automatic email or picking up the phone to call our representatives. As voting constituents, your voices speak much louder than the population we support. Keep an eye out on our social media and website for other opportunities to get involved.


